## ORDER NO. 1 EXTENDING EMERGENCY DECLARATION DUE TO HURRICANE IAN FROM 10/7/2022 TO 10/14/2022

AN ORDER OF MAYOR OF THE CITY OF ANNA MARIA, FLORIDA, EXTENDING THE DECLARATION OF A STATE OF LOCAL EMERGENCY DUE TO THE EFFECTS OF HURRICANE IAN PREVIOUSLY EXTENDED BY RESOLUTION NO. R22-783 AND RESOLUTION NO. R22-784 BY THE CITY COMMISSION OF THE CITY OF ANNA MARIA

WHEREAS, Section 252.38(3), Florida Statutes, authorizes the City of Anna Maria to declare a state of local emergency and to waive the procedures and formalities otherwise required of political subdivisions by law; and

WHEREAS, Chapter 2, Article VI of the City Code of the City of Anna Maria authorizes certain powers in the event of a local state of emergency; and

WHEREAS, a state of local emergency proclamation is allowed for seven (7) days with appropriate extensions pursuant to law; and

WHEREAS, Hurricane Ian has caused serious and widespread damages to the City of Anna Maria; and

WHEREAS, the Mayor of the City of Anna Maria (reference to whom shall also encompass the Chairman of the City Commission in the absence of the Mayor) has been granted broad powers to take all actions necessary and appropriate to protect human life and property, including the promulgation of rules and orders as may be necessary subject to the limitations of Section 252.33, Florida Statutes and to utilize all lawful authority granted to the City of Anna Maria by Federal, State, County, or City Emergency Management Laws, Rules, Regulations, Orders and, including, but not limited to, Section 252.46 and Section 252.38(3)(a)(1) through Section 252.38(3)(a)(5), Florida Statutes, inclusive and as also provided in Resolution No. R22-783 and Resolution No. R22-784; and

WHEREAS, the City of Anna Maria must continue to take timely actions to protect public and private property and members of the public from the results of Hurricane Ian; and

WHEREAS, it is determined by the Mayor that the state of local emergency should be extended for the City of Anna Maria.

**THEREFORE**, under the powers vested in the Mayor of Anna Maria pursuant to Chapter 252, Florida Statutes, and under the City's Code of Ordinances, and the previously adopted Resolution No. R22-783 and Resolution No. R22-784 of the City Commission of the City of Anna Maria extending the declaration of emergency, the Mayor does hereby extend the declaration of the existence of a state of local emergency in the City of Anna Maria, Florida, as identified above from 10/7/2022 to 10/14/2022.

DONE AND ORDERED THIS 7th DAY OF October, 2022, the Mayor extends the Local State of Emergency and incorporates all provisions of Resolution No. R22-783 and Resolution No. R22-784.
