One original and ten (10) copies of the application package including copies of all supporting documents, exhibits, plans and specifications are to be attached there to with proof of properly notice public hearing attached to the original and Fee is to be submitted to the City of Anna Maria Building Department .

Please complete every item requested on the application. Do not complete an item by referring to a map or plan. Do not leave any lines on the application blank.

The City may request additional copies of the application packages as may be necessary to distribute to consultants.

The application will be scheduled for the next available Planning and Zoning Board meeting.

The City may, if deemed necessary, retain consultants to assist in the review of an application for Final Site Plan review. The cost of retaining the consultants shall be borne by the applicant in addition to the initial application fee. The applicant shall be responsible for making timely payment of all said consultant fees. Failure to do so will result in the City being relieved of its obligation to continue processing the application until the required payment(s) is/are made. The payment of all outstanding consultant fees shall be a condition of Final and Preliminary Site Plan approval and payment is a condition precedent to the City's obligation to issue a Building Permit.

Please be advised that no work covered by this application (including grading, grubbing and clearing) may be commenced.
