

CITY OF ANNA MARIA 2014 PERMIT FEE SCHEDULE

GENERAL

- 1 **All permits are subject to the following non-refundable fees.** Fees may only be waived by the City Commission. Fee waiver applications must be in writing. Overcharges and fees assessed in error will be refunded upon verification by the City Clerk and Building Official.
- 2 For ALL City of Anna Maria Permits - After-The-Fact fees are assessed at double the normal fee plus original fee. Waiver of any permit fees or after the fact fees requires approval of City Commission.
- 3 Permit Valuations will be determined from the proposal of work or contract signed by the owner and contractor. The valuation documentation must be submitted at the time of permit application. Permit fees based upon Contract values will be rounded up to the next dollar.
- 4 Post disaster valuations may be determined by the Building Official using the current ICC valuations table with regional multiplier or current estimating valuations.
- 5 For those permits requiring detailed plan review a plan review fee of 10% of the total Permit cost associated with Florida Building Code Compliance will be charged and collected. When permits require review from outside consultants the cost of such review shall be borne by the applicant. Permits may require LDR and Public Works Review in addition to Building Code Review; separate fees are established for those reviews.
- 6 NOTE: Permits for sub-contracted trades gas, plumbing, mechanical, and electrical are in addition to Building Permit Fees. For new and altered structures requiring a permit for any of the following trades, Gas, Plumbing, Mechanical or Electrical, a flat fee per trade will be charged. For separate trade permits refer to Section II.
- 7 A Building Permit Surcharge Fee of an aggregate 3 Percent of the fees associated with Florida Building Code Compliance will be collected for all Permits pursuant to Fl. Statutes 553.721 and 468.631
- 8 Where permits fall into multiple types, the highest application fee will be used as the base permit fee.
- 9 A Re-inspection fee will be charged for the 2st failed inspection. Repeat inspections are subject to Fl. Statute 553.80(2)(c). Re-inspection fees must be paid before re-inspection will be scheduled.
- 10 Repeat Plan Reviews for continuously noted violations are subject to Fl. Statute 553.80(2)(b).
- 11 Professional Staff Time or Professional Consultant review fees will be invoiced to the property owner or contractor where necessary. Where the City's cost exceeds any fee specified the applicant will be notified to pay the overage.
- 12 A Security (Performance) Bond for work in the right-of-way in the minimum amount of \$25,000 is required pursuant to Section 114-608 of the City Code of Ordinances
- 13 Beach Equipment items confiscated by the City and are not reclaimed will be auctioned every six (6) months. If items are held longer than seven (7) days, a storage fee of twice the normal fee will also be applied. Items will be photographed and marked identifying the location they were removed from.
